**Directions:** CW Elaine will be Chair of the Charter (*CW Brown Chaired several months*). CW Elaine will read the rules of the Charter meetings at the commencement of each meeting. This includes rules pertaining to conduct of citizens, staff and others. The recommended Charter is color-coded with each Councilmembers changes. Please review the Charter before the session. Each Councilperson shall speak on each Article session, twice. Any residents can speak at the conclusion of the meeting (*within the last 15-20 minutes of the meeting*) on any changes and/or questions they may have regarding "only" specific Charter Articles discussed that day..

**ATA/Town Clerk:** Please make sure an AGENDA is completed before each Charter meeting and given to ATA and CW Williams for the meetings. Since the dates will vary each week, you do not have to list the Charter Amendments to review. Also, please be sure that any "NEW" Resolutions or Ordinances (*since the last Charter update*) are forwarded to Mayor & Council to assure accurate update of the Charter.
